How to determine tuition invoice dates and due dates	The Environmental Practice program is a customized program of study. Tuition is invoiced based on individual completion plans and course start dates. All tuition must be paid prior to each course start date.		
	Tuition will be invoiced approximately 30 days prior to each course start date and due approximately 2 weeks before the course start date.		
	New course registrations less than 30 days prior to the course start date will be invoiced upon registration and will due prior to the course start date; due date will be stated on invoice issued.

	Self Paced Program Administration Fee: \$310.82 (invoiced annually on the anniversary of the program start)

The fee covers the additional administrative costs of the self paced program to include managing custom schedules and all letters of permission required to take courses at other institutions. *subject to fee increase each academic year
