**Tuition Payment Estimator**

This Tuition Estimator is provided to students to use as an informational budgeting tool; it is not an invoice. Tuition estimates are for the entire program.

Rates on this schedule are rounded for display purposes; a student's actual invoice will contain unrounded rate calculations.

All tuition and fees are invoiced based on individual student enrolments; any changes to enrolments, credit load, electives, or program duration may result in additional or increased fee rates.
