



Tuition Payment Estimator

Graduate Certificate in Strategic Human Resources Management

Tuition will be invoiced on the 1st of the month prior to the course start date and due on the 21st of the month prior to the course start date.

Example - a course starting any date in September will be invoiced on August 1st and due on August 21st

The tuition deposit is paid on acceptance into the program and is a pre-payment of tuition to be applied towards the first invoice

All invoice dates and due dates are subject to change (ie - dependent on program and individual schedule changes)

*Note: Students paying each year in full do not pay the installment fee *

Tuition will be invoiced on the 1st of the month prior to the course start date and due on the 21st of the month prior to the course start date.
Additional Ancillary fees may apply depending on program completion option:	Different completion options/electives may have additional fees not outlined on this form; additional fees may apply based on chosen completion option.
